It was developed to highlight the issue of FDA compliance in food labeling, especially for organic products. The fake product consists of a standard retail-style display box as well as an accompanying website complete with FDA label compliance training videos

(http://www.liveforeverjuice.com). Intended to be over-the-top, Live Forever Juice is intentional yet witty, honing in on some of the most common and difficult labeling errors that companies often make. The website explains the project and offers a set



of 6 training videos where various FDAImports.com staff members assess each label and address particular areas of compliance such as:

- The Nutrition Facts Panel
- Issues with Percent Juice Declaration
- · Fonts, Sizes and Location Issues
- Health Claims
- Organic Claims
